



## EXPRESSION OF INTEREST FOR COMMERCIAL FISHING LICENCES IN SOMALILAND

### APPLICATION DETAILS

Complete this expression of interest form so we can make an initial assessment of the potential and eligibility of your company for a fishing licence in Somaliland.

You must answer all questions as accurately as possible to provide us with sufficient information to process your application.

Anglo Somaliland Resources Limited (ASR) is a private company registered and based in the UK.

ASR has entered into a contract with the Government of Somaliland (GoS) that enables ASR the granting of fishing licenses for the whole of Somaliland's territorial waters as recognised by international law.

Somaliland has 850 km of coastline and an Economic Exclusion Zone (EEZ) of some 70,000 square km with extensive unexploited fish stocks.

Somaliland is a functioning state, with settled and defined boundaries which it controls. It covers exactly the same area as the former British Somaliland Protectorate and has separated from Somalia on 18<sup>th</sup> of May 1991.

ASR has determined a Total Allowable Catch (TAC) and stock quotas at 150,000 metric tons per annum and includes the following species : **Yellowfin Tuna, Eye Tuna, Skipjack Tuna, Albacore, Deep & Shallow Lobster, Swordfish, Sharks & Rays, Shrimps & Prawns, Mixed Group.**

ASR is able to ensure the granting of a licence for the whole annual TAC of Somaliland from 2017 onwards, or on quotas for specified tonnage.

The licences will be issued under a contract which will be subject to English law and the provisions of the UK Arbitration Act to resolve any disputes that may arise out of the licensing agreement.
